

Bull Run Olde Bulldogges

Purchase Agreement

PRINT AND SIGN THIS DOCUMENT AND SEND WITH DEPOSIT.

The buyer agrees to purchase a puppy with the identifying name _____ for the total amount, (not including shipping) of \$ _____. The name of the puppy's sire is _____ and the name of the puppy's dam is _____.

The puppy will be supplied with necessary health information, including all shot and worming records. The NBA. and /or the IOEBA registration applications will be signed and executed at the time of the purchase. If you desire, in addition and in the interest of maintaining the highest breeding standard, this puppy is also eligible for pet stock "Mountain Bulldogge" registration with the original Animal Research Foundation (ARF). After the puppy turns 24 months of age, a hip x-ray with the O.F.A. fee can be submitted to us or directly to the O.F.A. When 1)- proof of "normal hip" structure is provided from the O.F.A. to the seller. 2)- No other visible or apparent genetic defect has manifested in the dog. And 3)- Photos are determined to meet the breed standard. At no additional charge except registration fees, the dog will be eligible for permanent registration with the (ARF) as a breeding stock "Mountain Bulldogge" or Mountain line Olde English Bulldogge.

1. Puppies are reserved and held with a deposit. Deposits are \$300.00. Deposits can be paid with cash, money orders, personal checks or a major Credit Card through Pay Pal. Once Bull Run receives the deposit the puppy will be considered sold. Due to the prevalence of check fraud the balance on your puppy is due by the time the puppy is six weeks old. This gives us time for the check to clear our bank.
2. Choice of puppy is determined on a first come (deposit received) first to choose basis. Puppy will be placed on "hold" for four business days, while waiting for a deposit. If deposit is not received in that time, the puppy will be placed back up for sale.
3. Deposits are NON-REFUNDABLE, except in cases of premature death, prior to the delivery of your puppy to you. If you decide you do not want or cannot take your puppy you forfeit your deposit.
4. All shipping costs are the buyer's responsibility. This includes Vet certificate(s), kennel/crate, and any other actual shipping costs.
5. Puppies will not be released before they are eight weeks of age. If shipping or pick-up arrangements have not been made by the time the pup is ten weeks old, buyer agrees to pay a \$35.00 per week boarding charge, plus any other actual expenses incurred, until the pup is shipped. Two weeks or more with no attempts to make pick up arrangements or

attempts to make plans with Bull Run, the buyer then forfeits the puppy and any deposits or payments made to date, absent written agreement from the seller.

YOUR EXCLUSIVE BULL RUN PUPPY GUARANTEES

Bull Run is the number one O.F.A. certified Olde English Bulldogge breeder. Our screened stock is eligible for exclusive registration with the original Animal Research foundation as Mountain Bulldogges a.k.a. Mountain line O.E.B.s This accomplishment along with our documented history, track record and screening program is evidence of our commitment to breeding for health and quality first. We do not breed dogs with undesirable conditions such as mange or bad hips etc., but we cannot guarantee that previous generations did not have these conditions in their lines; because of this and the nature of recessive heredity we can not guarantee these conditions will not show up unbeknownst to us in future litters. Bulldogges are not perfect, not even ours but we are committed to a responsible up-breeding program and unless otherwise noted, we exclusively guarantee all of our breeding stock, x-rayed and screened for hip dysplasia with documentation on hand.

Seller guarantees animal to be in good physical condition for the first 72 hours after the time of delivery to the buyer. The Buyer agrees to have the puppy examined by a licensed veterinarian within 72 hours after delivery time for a complete examination. If the veterinarian finds the puppy to have a serious physical condition other than a viral or bacterial cold or bacterial infection, such as coccidia or giardia, which is easily treated, the seller will replace the puppy with another puppy of comparable or better quality, when available from same or subsequent litter(s), after the original puppy is returned to the seller. The seller reserves the right to a second veterinarian opinion at the expense of the seller. Failure to have the puppy examined by a veterinarian within 72 hours after delivery voids this guarantee. No monies will be refunded. Please consider a puppies immune system may be stressed after leaving its home and littermates. Give him time and keep him away from stress and germ-friendly atmospheres for 10 days or so. Hold him in your lap at the vet.

We also guarantee against genetic defects that come from our breeding program. Said defects should be evident by the time the dog is an adult at two years of age and we guarantee dog until that point. If a genetic defect is found, we will exchange your puppy with another of equal value, subject to a veterinarian's signed and dated statement of the puppy's genetic condition and the cause of that defect or condition, subject to review of a veterinarian of seller's choice at seller's expense. The seller is not responsible for defects/conditions caused by buyers neglect, abuse, improper nutrition, mishandling or any injuries to puppy caused by said conditions. Breeding or participation in extreme sports voids this guarantee.

Buyer Agrees:

1. To use the kennel name "Bull Run's" as the prefix in the registered name of the dog, and will not represent the dog as a product of his/her breeding.
2. To maintain up-to-date vaccines, wormings and to keep the puppy / dog in humane living conditions, providing proper food, water and shelter.
3. In the event the dog is later sold, or otherwise transferred from the possession of the buyer for any reason, the seller will have absolute right of refusal to repurchase the dog for a sum not to exceed the original purchase price.

The buyer and seller agree that this is the full and complete agreement that exists between the parties for sale of this dog/puppy.

Any agreements made prior to this are considered incorporated herein and any modifications made to this agreement shall be made in writing, or such shall not be effective.
